Oracle Jipher makes these cryptographic services available for Java developers using the standard JCA framework.

Oracle Jipher is offered as part of the [Oracle Java SE Universal Subscription](#) and to Oracle customers running Java workloads in Oracle Cloud Infrastructure (OCI).

This document covers only your entitlement for Oracle Jipher. [Oracle Java SE Universal Subscription](#) also grants you rights to other features. Please review the licensing information user manual for Java SE versions to learn about your rights associated with those Java SE versions.

### Prerequisite Products

Jipher 10 requires a current update release of Oracle JDK 17 or 21, or GraalVM for JDK 17 or 21.
